# Xstrata Mount Isa Mines opens new accommodation precinct 'Thilimarri Place'

Mount Isa, Thursday 22 October 2009

Xstrata Mount Isa Mines today joined the Kalkadoon Community Pty Limited in officially opening the company's new accommodation precinct 'Thilimarri Place' in Oban Road, Mount Isa.

Steve de Kruijff, Chief Operating Officer Xstrata Copper North Queensland, said the project was a sign of the company's strengthening relationship with the people of the Kalkadoon community and a testament to the efforts of the company's Indigenous trainees.

"I am very proud of this project as it's a great example of what can be achieved when we work side by side with a valued community stakeholder and encourage the use of our Indigenous trainees' skills," said Mr de Kruijff.

Thilimarri Place comprises nine eco-friendly duplexes, each containing two three-bedroom units which have been built with environmentally sound features such as energy efficiency and passive cooling, compact fluorescent bulbs, reverse cycle refrigerative air-conditioning, greywater diverter systems and 4-star rated water efficient toilets and showers.

Mr de Kruijff said the company settled on the name of 'Thilimarri' in consultation with the Kalkadoon community.

"The name *Thilimarri* represents the Gidgee tree which plays a significant role in the Kalkadoon community and family life, as it provides food, medicines, shelter and tools for protection and survival," said Mr de Kruijff.

"This name acknowledges the relationship of the Kalkadoon people with the lands, language and cultural heritage of the Mount Isa region."

Doug Bruce, Chairman of Kalkadoon Community Pty Limited, said he was pleased the Kalkadoon community had the opportunity to work with Xstrata Mount Isa Mines on the project.

"Today is a special day for us as not only is the precinct built on the land of the Kalkadoon, we are also delighted that the Kalkadoon people and community are being recognised through the naming of the precinct," said Mr Bruce.

"We are confident that this is the start of a strong and productive relationship with Xstrata Mount Isa Mines that will continue into the future."

Mr de Kruijff said through Xstrata Mount Isa Mines' Structured Training Employment Program, the company's Indigenous trainees were given the opportunity to contribute to the development of the \$4.5 million accommodation precinct.

"From undertaking landscaping and gardening to the setting up of all 18 units, furnishing and cleaning, our trainees were involved in every stage throughout the project," said Mr de Kruijff.

Together with the Elders of the Kalkadoon community, Mr de Kruiff officially opened Thilimarri Place at a plaque unveiling ceremony at 2:00pm today in Oban Road, Mount Isa, which was attended by key stakeholders of the local community.

# **Notes to editors**

#### Xstrata Plc

Xstrata is a major global diversified mining group, listed on the London and Zurich stock exchanges. McArthur River zinc-lead mine in the Northern Territory, Australia; the Northfleet lead refinery located in the UK; the Brunswick zinc-lead mine and lead smelter in New Brunswick, Canada, 25% of the CEZ zinc smelter near Montreal, Canada; 50% of Lennard Shelf zinc lead mine in Western Australia; 75% of Lady Loretta zinc lead deposit in Queensland, Australia; 33.75% of Antamina mine in Peru and the Perseverance zinc deposit in Quebec.
